While the ways in which Uplift delivered grief support programming changed drastically in March 2020 due to the Covid-19 pandemic, the organization was still able to serve more than 3,100 children, youth, caregivers and professionals over the year through its School & Community, Family Services, Post-Crisis Response, and Training programs. The trajectory of programs from September 2019 to March 2020 shows a steady climb in numbers of participants, indicating the organization was on track to serve an increase of over 32% more individuals over the prior year had COVID-19 not struck.
